#### The Position:

The Technical Advisor, seconded to the coordination of the reproductive health sector in Benin, is responsible for the strategic accompaniment of the program of "Extension and Strengthening of the Sexual and Reproductive Program of Adolescent and Youth in Benin", funded by the Netherlands as a direct contribution to the National Strategy for Sexual Health Education for Young People.

The technical advisor will ensure the full synergy of program interventions with the others normative frameworks of the Government of Benin and the interventions of other technical and financial partners. In this context, s/he will ensure the implementation of appropriate strategic and operational coordination mechanisms for a synergy of interventions and results, with a human rights and gender based approach.

The advisor will be also nurturing the development of strategic partnerships to support national efforts to explore innovative ways to scale up results, including with enhanced use of social and/ or digital innovations, and enable the sector to go from funding to financing.

S/he will report to the UNFPA Representative and will work in close coordination to the General Directors in charge of adolescent health at the Ministry of Health and Ministry of education.

## Job Purpose:

Working within a diverse and dynamic Country Office (CO) environment, you will ensure the development and support to strategic partnerships in the area of adolescent and youth reproductive health and Rights, with a strong gender lens.

You will establish, nurture and develop collaborative and innovative partnerships with counterparts in government, multi-lateral and bilateral donor agencies and civil society to address emerging issues, and effectively influence diverse stakeholders to contribute to achieving the program's objectives.

In collaboration with the national counterparts and partners, you will contribute substantially to increasing coverage of Comprehensive sexual education for reduced early pregnancies and contraceptives unmet needs and improving the availability and accessibility of reproductive health services quality, with active youth/girls empowerment and community involvement.

Employing your programme management experience, you will guide the work of the programme team as well as consultants, advisors, and experts and support the quality of interventions and outcomes: (i) best practices and lessons learned in the management of the work plan, (ii) leadership, governance, coordination, monitoring and evaluation at all levels of the health pyramid for the promotion of Family Planning, and Gender for accelerating unmet family planning needs and Benin's sustainable development goals.

#### You would be responsible for:

The Technical Adviser (Adolescents and Youth) will coordinate, manage and provide quality, timely and integrated technical assistance, policy and programme support and strategic guidance on Adolescents and Youth including strengthening national capacity for integrated ASRH programing and CSE for in-school and out-of-school youth.

## Specifically, the advisor will:

- Assess existing interventions and capacities in the ASRH in Benin and develop a strategic
  partnership framework in the field of CSE, family planning and protection of sexual and
  reproductive health and rights of young girls showing synergies, complementarities, any
  duplication. This summary document will have articulate a clear strategic vision, taking into
  account the United Nations Development Assistance Framework (UNDAF) and show interactions,
  complementarities, potential duplication with the action plans of sister agencies and other
  interventions supported by the Netherlands and other bilateral cooperation in the sector.
- Act as an enabler of the development and implementation of innovative and gender-sensitive strategies and business models for accelerated and scaled up results in the area of Sexual and Reproductive Adolescent Health and Comprehensive Sexual Education, including with strengthening digital strategies, and social innovations, including with community, traditional and religious stakeholders
- Strengthen national capacities for: i) enhanced coordination of the reproductive health sector; ii) sound costing and financing exercises to accelerate the close of the funding gap; iii) efficient political dialogue for growth and equitable distribution of qualified heath providers and equitable access to reproductive health and education services, with a focus on the youth the most at risk of being left behind; v) innovation initiatives in the sector; vi) improved monitoring and evaluation;



- Participate in the implementation and monitoring of Annual Work Plan activities of counterparts by conducting field visits, participate in review meetings and missions' evaluation
- Assess existing data systems and exploit studies and research available in Benin regarding Comprehensive sexual education and AYSRH and support national capacities with a view to ensuring the availability of dashboard of indicators on RH/SR-AYRH-CSE.
- Contribute to the creation and sharing of knowledge by synthesizing and documenting the results, lessons learned, successes and best practices, strategies and innovative approaches to promoting adolescent and youth reproductive health and rights, with a specific attention on the youth most at risk of being left behind;
- Perform other tasks as requested by the supervisor in the area of his/her competences.
